Key Holder Application 2017

Key Holder Rules Key Fee: \$150.00

- 1. You must be a full financial member of the Club.
- 2. You must have a current MWA competition license.
- 3. You must hold a current MWA officials license.
- 4. Club membership card and MWA competition license must be carried at all times and presented to the club members or officials on request.
- 5. Your current race number must be on the motorcycle you are riding.
- 6. NO MEMBER IS PERMITTED TO BRING A NON-MEMBER INTO THE TRACK TO RIDE. MEMBERSHIP WILL BE TERMINATED.
- 7. Track is closed when the "CLOSED SIGN" is hung on the gate.
- 8. You must re-lock the gate upon entry and departure. If you leave the gate open and a non-member enters the track you could be fully liable if an incident occurs.
- 9. You must obey all officials' requests at all times.
- 10. You must personally inspect the track before riding and satisfy yourself the conditions are safe and acceptable for riding.
- 11. Fully approved clothing and protective clothing is to be worn at all times whilst riding.
- 12. No riding is permitted off the race circuit at any time.

Breech of these rules will attract a three-month suspension as a minimum penalty.

Upon Acceptance as a Key Holder, I Agree To: -

- 1. Obey all club rules and regulations.
- Inspect the track before use and agree that by using the facilities for participation of motorcycle riding, that I am accepting all risks, dangers and obligations at my own risk and responsibility.

These rules must be adhered to when joining the AJS Motorcycle Club of WA Inc.

- Sign on sheets are to be signed prior to you taking the track for practice.
- Inspect the track prior to riding.
- Please DO NOT cut the track, it ruins the reticulation.
- NO non-members are permitted to ride at AJS Motorcycle Club Inc.
- AJS Motorcycle Club Inc supports the <u>NO HASSLE POLICY</u> put forward by MWA and in your Manual of Motorcycle Sports. This policy includes Officials and Volunteers of the Club.

Flagging:

- You will be required to supply 2 flag marshals per season.
- You will be charged a fee of \$120.00 of which you will receive a refund on completion of your duty \$60.00 per duty completed.
- If you do not show up for your flag roster on your designated days, there will be no refund, you will be unable to ride until your duty has been fulfilled.
- You may opt to pay a flag days waiver fee to the club of \$200.00 for the club to supply flag marshals in lieu of member supplying.

Busy Bees:

- You will be required to do 2 busy bee per member per year.
- On your designated days you will report to the Venue Manager to receive your jobs for that day.
- If you are unable to attend your busy bee day you may opt to pay a fee of \$100.00 to the club or book in for another day.
- If you <u>DO NOT</u> book in for another busy bee or pay your \$100.00 you will be unable to ride
 until such time as you have re-booked or paid the fee.
- You may opt to pay a busy bee waiver fee to the club of \$200.00
